PROFESSIONAL EXPERIENCE

- Director of Wind Ensemble Activities and Clarinet Professor – Berry College
Currently, I am the Director of Wind Ensemble Activities at Berry College. I started this position in July of 2012. I oversee and conduct the Wind Ensemble and also am the clarinet professor. In addition I teach music education courses such as wind band literature and marching band techniques.
- Clarinet Performances – Atlanta, Georgia
As the clarinet professor at Berry College I present clarinet recitals yearly, collaborating with other Berry faculty. In addition, I visit high schools in metro Atlanta as well as locally in Rome, GA and present clarinet master classes. My college clarinet majors have won two concerto competitions since my arrival at Berry in 2012.
- Conductor's Lab Participant – Aix en Provence, France
During July of 2012, I was one of 7 participants chosen to conduct chamber music with members of the Berlin Philharmonic in the South of France.
- Guest Clinician – Atlanta, Georgia
I have served as guest clinician for numerous high schools in the Cobb County and surrounding metro-Atlanta areas such as Lassiter High School, Pope High School, Hillgrove High School, Pickens County High School and McEachern High School as well as at Georgia Tech and Marywood University (Pennsylvania). I have also had the pleasure of working with local Rome middle and High Schools.
- Director of Bands – Oklahoma Baptist University
From the fall of 2010 to spring of 2012, I served as the Director of Bands at Oklahoma Baptist University where I oversaw all aspects of the Band division and conduct the Symphonic Winds. While at OBU I reinstated the flute, clarinet and saxophone choirs and teach Marching Band Techniques, Advanced Conducting, Wind Band Literature, and Woodwind Methods. I also was the Clarinet Professor and Instrumental Music Education supervisor. I represented the University at the National CBDNA convention, and recruited at OMEA and TMEA.
- Artistic Director of the Oklahoma Baptist University Regional Honor Band

I am responsible for all logistical and artistic facets of the annual OBU Regional Honor Band held at Oklahoma Baptist University. The event draws approximately 300 junior high and high school students each year and culminates in a performance from two large ensembles conducted by nationally renowned guest conductors.

- Guest Clinician – Oklahoma

I have served as guest clinician at Southeastern Oklahoma State University, and numerous high schools across the state of Oklahoma, Georgia, and will be travelling to Pennsylvania in November of 2012 as a guest clinician.

- Teaching Assistant in Instrumental Conducting – University of Miami

From 2007 to 2010, I served as a Graduate Teaching Assistant in the Instrumental Conducting department at the University of Miami. Responsibilities included conducting rehearsals and performances with the Frost Wind Ensemble, Symphonic Winds, Frost Chamber Winds and University Band. In addition, I worked with the “Band of the Hour” marching band during both music and drill rehearsals. I also conducted the Volleyball pep band and both the men and women’s basketball pep band. I represented the University of Miami Frost school of Music in Atlanta, Georgia at a college fair held at Pebblebrook High School and was actively involved in recruitment for the “Band of the Hour” during freshman orientation.

- Woodwind Instructor for the Kennesaw Mountain High School Marching Band – Kennesaw, GA

Between 2003 and 2009, I worked as the head woodwind instructor for the Kennesaw Mountain High School Marching Band, under the direction of David Starnes. I was fortunate to take this ensemble to the Bands of America Grand National Championships three times and attend numerous regional competitions throughout my six seasons there.

- Commencement Band Conductor – University of Miami

I was responsible for all logistical and musical responsibilities related to the performance of the Fall and Spring Commencement Band. This performance was given for approximately 6,000 people, which is the largest audience of the academic term.

- American Bandmasters Association – Miami, Florida
In March of 2008, the Frost School of Music at the University of Miami hosted the American Bandmasters Association (ABA) Conference. I was deeply involved in all aspects of planning including hosting guest ensembles and conductors, scheduling, and concert program design.

I held an active private studio of over 45 students while teaching the metro Atlanta area. In addition, I have had great experience teaching and providing master classes throughout the metro Atlanta area including schools such as Kennesaw Mountain High School, Pope High School, Kell High School, Hillgrove High School and Lassiter High School.

From 1999-2000 I performed studio work in Nashville for the movie “Ancient Evil” and background music for a live radio reading of “The Secret Garden.
